

JULIUS BAER IN THE ACQUISITION OF MERRYL LYNCH

Julius Baer's Merrill Lynch buy closes in four jurisdictions

Twelve firms, including in Chile and Uruguay, have helped Switzerland's leading private banking group Julius Baer acquire Merrill Lynch's international wealth management businesses outside the US.

The deal closed in Chile, Uruguay, Switzerland and Monaco on 1 April. Julius Baer agreed to purchase the businesses for a total of US\$880 million from parent company Bank of America in June last year.
